Met Expectations in ELA almost doubled from 16.3% to 29.8%.</li> <li>2020 graduates that were College &amp; Career Ready was only 3.3%, in 2021 it jumped to 39%.</li> <li>Increased the number of students attempting &amp; completing CTE Pathways</li> <li>Graduation rate decreased, but that's a result of late enrollment 11th &amp; 12th graders who had to graduate Adult Track.</li> </ul>
